FIREBIRD Proposal - 2010 MSU Space Physics REU

SIMULATION OF THE PRECISE SEPARATION OF A TWO-NANOSATELLITE SYSTEM USING DIFFERENTIAL DRAG AND PASSIVE ATTITUDE STABILIZATION VIA MAGNETIC HYSTERESIS

1 Goals

I am planning on writing a program to numerically determine the low-earth-orbits and attitudes of the two satellites of FIREBIRD with a variety of modified structural conditions. The main program would determine at least three important details about the FIREBIRD mission:

- The time it takes the satellites to reach a maximum separation distance between them, double back upon themselves, and to reach that distance in the opposite direction, given a certain difference in mass between them and initial separation speed.
 - A slight difference in mass between the satellites leads to a different ballistic coefficient.
 - The different ballistics of the satellite lead to differential drag between them in a low-earth-orbit with atmospheric drag forces.
 - Differential drag will cause the leading satellite to lose its initial separation speed with respect to the lagging satellite; the separation distance between them will then reverse and close, and the leading satellite will eventually lag behind until a separation distance is achieved in the opposite nature.
 - Given a mass difference between the satellites, the mission duration can be effectively increased without changing the original separation velocity.
- 2. The time it takes the attitude of each satellite to stabilize, given the structural design of the bar magnets within FIREBIRD.
 - The satellites each have passive attitude control, where they shift their attitude to line their bar magnets up with Earth's magnetic field.
 - Engineers use materials with magnetic hysteresis to provide forces which dampen out natural oscillatory attitude movements and eventually stabilize the attitudes.

- 3. The effect of having the satellites separate along a vector that points in a different direction from their center-of-mass velocity vector, or separate at a very different speed than the one planned.
 - Having the satellites separate in a direction that is different from direction the two satellites are traveling before separation could drastically change each satellites individual orbits and the mission duration.
 - Having the satellites separate at a different speed could drastically change the mission duration.
 - The project requires a test to see how much error can be introduced into the separation velocity vector before mission failure.

2 Programming Outline

- 1. The program shall be written in MATLAB.
- 2. Loops should be replaced with vectors as much as possible, to improve program efficiency.
- 3. Numerical evaluation should use a fourth-order Runge-Kutta method to increase accuracy.
- 4. The program shall utilize geodetic Newton's Laws of gravity.
 - The earth shall be assumed to be an ellipse, using the J2 Earth gravitational harmonics.
 - The numerical evaluation of physics equations should use Earth-Centric-Inertial Cartesian coordinates.
- 5. The program should be as accurate as possible over the simulation time.
 - The numerical step size should be no larger than 3-5 seconds.
- 6. The atmospheric drag associated with LEO must be accurately accounted for.
 - The atmospheric density must be represented by the NRLMSISE-00 Atmospheric Model at each step.
 - The geodetic location of the satellite in orbit must be known at each step.
 - The satellite surface area through time must be accurately represented, determined by its attitude with respect to its velocity vector.
- 7. The attitude of the satellite must be known at each step.
 - The attitude is controlled by passive attitude control; the Earth's magnetic field must be represented by the IGRF Geomagnetic Model.
 - The attitude is stabilized through magnetic hysteresis; the physics must be understood and the errors from any simplifying assumptions must be negligible.
