# Magnetic Properties of Active Regions and Solar Irradiance

- Aim: Constrain first-principle-based models of AR irradiance
- Relevant timescales ~ seconds, minutes, days
- Physical processes: Energy storage and release, reconnection
- Method: Compare AR magnetic parameters to irradiance indices

## Relevant AR parameters:

- B: Average field strength
- A: Area
- **Φ**: Flux
- L: Coronal loop length ( $\pi d/2$ )
- q: Field line twist (density)

Notes:

- Magnetic energy density ~  $B^2/8\pi$
- Twisted (non-potential) flux systems store excess energy – drives plasma relaxation (Nandy et al. 2003)

- Mgii

- UV
- EUV
- X-ray

Magnetic Properties of Active Regions and Solar Irradiance

#### Progress

- Used Haleakala Stokes Polarimeter vector magnetogram data
- Reduced to generate relevant magnetic parameters
- Database contains more than 1000 ARs spanning 1988-2002
- Future : Comparison of magnetic parameters to irradiance measures



(X-ray Luminosity versus twist, Nandy 2008, see also Fisher et al. 1998)



(Left: Faculae and spot observed by Swedish Solar Telescope, Tickmarks: 1.34 arcsec) (Right: TSI model, Sunspot darkening and facular brightening, Frohlich & Lean 2004)

- Aim: Understand flux redistribution between spot and faculae
- Relevant timescales ~ days to solar rotation
- Physical processes: AR decay and flux fragmentation
- Method: Use magnetogram partitioning algorithm to follow evolution

# **Development of Magnetogram Partitioning Algorithm**

- Downhill gradient based tessellation (Schrijver et al. 1997)
- Identifies fragments based on tessellation threshold (specified based on noise considerations)
- Global maximum chosen as first fragment and subsequent local maxima as different fragments
- Subsequent merging based on saddle-point, area and flux thresholds



- Left: HSP AR 6615 observed by HSP Resolution: 5.6 x 5.6 arc-sec
- Right: AR 10940 observed by Hinode/SOT Resolution: 0.3 x 0.32 arc-sec Faculae identification now possible



(FIR function for TSI and sunspot area, Preminger & Walton 2005)

- Dip in TSI from sunspot appearance gives way to positive contribution within a solar rotational timescale
- Future: Partitioning algorithm will be used to study this evolution
- Progress: Partitioning code has already been developed

## Modeling Total and Spectral Solar Irradiance

Aim: Build empirical models to constrain theoretical AR models Method: Assimilate observational constraints through statistical analysis

### Active Region Model (Time-Independent)

• Use observed relationship between magnetic parameters and measures of irradiance, and partial correlation analysis to constrain the parameters (c,d,e,f) in:

$$\Delta \mathbf{X} \sim \mathbf{B}^{\mathrm{c}} \times \mathbf{A}^{\mathrm{d}} \times \mathbf{L}^{\mathrm{e}} \times \mathbf{q}^{\mathrm{f}}$$

• This kind of empirical relationship will constrain first-principle based AR loop heating models, e.g., pursued by others (Klimchuk et al...)

Modeling Total and Spectral Solar Irradiance

## (Implicitly) Time-Dependent Models

• Use observations to construct Finite Impulse Response (FIR) functions

Suppose that X varies from its minimum level by an amount:  $\Delta X = X(t) - X_{min}$ 

Assuming that the index X varies in response to a physical impulse, say AR parameter A, this response can be modeled through a convolution using a FIR  $-h_x(t)$ 

$$\Delta X(t) = A(t) \times h_{x}(t)$$

- This approach can be used to model long-term irradiance variations

## The Sun—Climate Link



- The Sun radiates in different wavelengths: X-Rays, UV, Visible...
- This radiation is modulated by solar magnetic activity
- Solar activity also modulates galactic Cosmic Ray (CR) flux
- These may be the physical means through which solar forcing occurs
- Motivation: Study link between this solar forcing and global climate

## Physical Basis of Solar Forcing: The Total Solar Irradiance – TSI



- TSI: Spectrally integrated total solar radiation
- Average value of 1366  $W/m^2$
- TSI is the primary radiative energy input into the Earth system

### Variability of the Total Solar Irradiance – TSI



- TSI is modulated and varies (in phase) with solar magnetic activity
- Therefore it provides a link between solar variability and climate
- TSI observations exist only from 1978

# Physical Basis of Solar Forcing: Modulation of Cosmic Rays



- Sunspots contribute to the evolution of the solar open magnetic flux
- The solar open flux defines the heliosphere
- The magnetic flux in the heliosphere modulates cosmic rays

### Solar Modulation of Cosmic Rays



- Solar activity modulates cosmic rays (in anti-phase)
- Cosmic rays may affect climate by seeding clouds (Svensmark 1998)
- Hypothesis controversial (Carslaw, Harrison & Kirkby 2002)
- CR flux observations exist only from 1951

#### Methodology: Reconstruction based on Sunspot Numbers



- Reconstruct TSI and CR variation going back to 1600 AD
- Use simplistic empirical models of observed relationships, based on co-temporal TSI, CR flux and sunspot number (SN) data
- Calculate net solar forcing by making some assumptions regarding the radiative equivalent of CR variability and adding this to TSI variability
- Compare net solar forcing to global climate records over same period

## TSI Modeling



- Left: Observed daily TSI (PMOD composite) versus SN
- Right: Annually averaged TSI versus SN Linear correlation coefficient = 0.96
- On long-term averaging, the relationship seems to be fairly linear

#### **TSI Variability Reconstructions**



- Left: Reconstructed versus Observed TSI (linear correlation = 0.97)
- Right: Reconstructed TSI time-series based on GSN (orange), ISN (blue), and observed (black)
- Good agreement between reconstructed and observed time-series

## Cosmic Ray Flux Modeling



- Left: CR flux (CLIMAX neutron monitor) versus SN (annually averaged data), Linear correlation = -0.83
- Right: Reconstructed versus observed CR flux Linear correlation coefficient = 0.85
- Significant scatter in the fit, nonetheless correlation still significant

#### Cosmic Ray Flux variability Reconstructions



- Reconstructed CR flux time-series based on GSN (orange), ISN (blue), and observed (black)
- Fair agreement: Comparative amplitudes of maxima and minima preserved, although exact matching is not recovered

#### Estimating the Net Solar Radiative Forcing

- We want to estimate the net solar forcing based on TSI and CR flux
- For this we first assign the Maunder minimum level as the basal level
- Subsequently, we estimate the radiative forcing due to TSI relative to this basal level
- Svensmark (1998) claims that a 1% change in CR flux is equivalent to a change in radiative forcing of 0.42  $W/m^2$
- We <u>assume</u> that this is the case, and estimate the radiative forcing due to CR flux variations relative to its basal level (the working hypothesis is that more cosmic rays = more clouds = more incident energy reflected away = less net energy input into the Earth system)
- Finally, we add the radiative forcing due to both TSI and CR flux variability to calculate the net solar forcing

#### Net Solar Forcing versus Global Temperature Changes Since 1600 AD



#### Comments: Net Solar Forcing and Global Temperature Changes

- Global temperature anomaly is based on Mann et al. (1998)
- Both the temperature and solar forcing data has been smoothed with a locally weighted scatter plot smoothing using a linear least square fitting method to highlight the long-term trends (green curves)
- We note that simplistic co-temporal correlations between solar forcing and global temperature records are not necessarily evident, even before the pre-industrial era
- It seems that changes in solar forcing have an effect with a certain time delay in the global temperature record (note the relative positions of peaks and troughs)
- Note that the post 1800 AD enhancement in solar forcing did not reflect much in the temperature record (which actually kept fairly low)
- This may be due to the Tambora volcanic eruption in Indonesia in 1815 AD; volcanic eruptions are thought to result in global cooling
- In the 20<sup>th</sup> century, although solar forcing did increase, it is tending to flatten out. However, the global temperature curve continues to rise

## **Conclusions**

- This simplistic analysis taught us the Sun-Climate link is not simple
- Co-temporal correlations are not easy to find between solar forcing and global temperature changes; often the latter lags the former
- We should take into account the cooling effect of volcanic eruptions as this may play a role in disentangling the Sun-Climate link
- Solar forcing did rise in the 20<sup>th</sup> Century, but it seems to have stopped doing so (that is, if you believe in the smoothing); however, the global temperature rise has not slowed down
