ALTERNATIVE DERIVATION OF BOUND CHARGES (CCK VERSION)

(1.5)

Impaints a matterial made of "Atoms" (OR molecules) OF Volume V, and contraining Equal and opposite charges +9 (NUCLED) AND -9 (Electrons). IT may Have TO THINK OF THESE CHARGES AS OVERLAPPING SPHERCEL.

IF THE NUCLEUSE ELECTRON CLOUD HAVE THE SAME CONTROL THE DIPOLE MOMENT IS REPORT IF THE POSITIVE CHARGES ARE DISPLACED BY J (OR THE NEGATIVE BY -J), THEN p = 2J. NOW THINK OF J AS A VOLT CONTINUOUS VECTOR FIELD OF DISPLACEMENTS. THE DIPOLE MOMENT PER VOLUME IS = 2J

$$P = \frac{6}{V} = p_{ed}$$

IF A LORGE VOLUME I CONTAINING MANY ATOMS HAS DISPLACEMENT J(F), THEN THE LOSS (OR GAIN) OF CHARGE THROUGH THE SURFACE IS

$$\Delta Q = \begin{cases} (p, \vec{d}) \cdot d\vec{a} = \int_{Q} \nabla \cdot \vec{P} \, d\tau \quad (i) \end{cases}$$

THIS LOSS OF CHORGE CAR ALSO BE SEEN AS ARISING FROM NONZERO IN NET CHARGE DENSITY IN THE MOTERIAL:

MATTIX APPROACH:

$$V(\vec{r}) = \int \frac{\hat{\lambda} \cdot \vec{p}(\vec{r}') d\tau'}{4\pi \epsilon_0 \Lambda^2}$$
This is how

$$\nabla(\vec{r}) = \int \frac{\hat{\lambda} \cdot \vec{p}(\vec{r}') d\tau'}{4\pi \epsilon_0 \Lambda^2}$$
But $\frac{\hat{\Lambda}}{\Lambda^*} = \nabla'(\frac{1}{\Lambda})$, so

$$V = \frac{1}{4\pi \epsilon_0} \int \vec{p}(\vec{r}') \cdot \nabla'(\frac{1}{\Lambda}) d\tau'$$
Now integrate by parts using the product rule:

$$\nabla \cdot (\frac{\vec{p}}{\Lambda}) = \vec{p} \cdot \nabla'(\frac{1}{\Lambda}) + \frac{1}{\Lambda} \nabla' \cdot \vec{p}$$

$$\Rightarrow V = \frac{1}{4\pi \epsilon_0} \int [\nabla' \cdot \vec{p} - \frac{1}{\Lambda} \nabla' \cdot \vec{p}] d\tau'$$

$$\therefore V = \int \frac{\vec{p} \cdot \hat{n} dn}{4\pi \epsilon_0 \Lambda} - \int \frac{\nabla' \cdot \vec{p}(\vec{r})}{4\pi \epsilon_0 \Lambda} d\tau'$$
